AIR PRODUCTS SIGNS SOE CONTRACT FOR THE SUPPLY OF TWO PSA UNITS FOR HYDROGEN PRODUCTION IN UZBEKISTAN

The Fergana Oil Refinery was commissioned in 1959 and is one of the largest enterprises in the oil industry in Central Asia. Now the enterprise produces 60 types of petroleum products and fuels and lubricants.

The Fergana Oil Refinery has started the reconstruction of existing and construction of new production facilities, according to the approved modernization project, the total budget of which is estimated at \$ 300 million. In 2020 – 2023, the modernization envisages the introduction of the hydrocracking process at the refinery, and from July 1, 2023, launch of production of aviation kerosene, oils, as well as an increase in the fuel processing depth over 92% for production of Euro-5 diesel fuel.



Within the framework of the modernization project, the Fergana refinery selected Air products as a supplier of two PSA units for the production of hydrogen PK 301 and PK 401, with a capacity of 10,000 and 12,000 m³/h. Negotiations for the sale of the units continued from the end of 2020 and ended with the signing of the contract in September 2021.
